# **SUPERINTENDENT'S REPORT AND RECOMMENDATIONS June 26, 2017**

#### 1. AGREEMENT WITH A.F.S.C.M.E UNION – Attachment # 1

It is recommended that the board approve the three (3) year negotiated agreement between the South Williamsport Council 86, American Federation of state, county and municipal employees AFL-CIO Association and the negotiating committee of the School Board.

#### **2. RESIGNATION** – Attachment #2

It is recommended the school board accept the letter of resignation from Ellen Benfer as Percussion Instructor effective immediately.

## 3. **EMPLOYMENT** – Attachment # 3

## High School Guidance Counselor – 10th – 12th Grades

It is recommended the school board approve the employment of Kelsey Shannon as a High School Guidance Counselor for grades 10-12. This position is a 200 day position. Her salary will be \$52,662 based on step M-1 of the 2017/18 salary schedule of the Collective Bargaining Agreement.

## English Teacher – Grade 9

It is recommended the school board approve the employment of Melissa Mix as an English Teacher for Grade 9. Her salary will be \$53,622 based on step B-6 of the 2017/18 salary schedule of the Collective Bargaining Agreement.

#### Special Education Teacher – Elementary/Itinerant Support

It is recommended the school board approve the employment of Jonelle Beaver as a Special Education Teacher – Elementary/Itinerant Support. Her salary will be \$44,622 based on step B-1 of the 2017/18 salary schedule of the Collective Bargaining Agreement.

#### **Health & Physical Education – Elementary**

It is recommended the school board approve the employment of James Girardi as a Health & Physical Education Teacher for grades K-6. His salary will be \$44,622 based on step B-1 of the 2017/18 salary schedule of the Collective Bargaining Agreement.

#### Full Time Custodian – 3rd Shift

It is recommended the school board approve the employment of John Stiner as a full-time custodian effective June 27, 2017. His rate of pay will be \$9.00 per hour in accordance with the A.F.S.C.M.E. Collective Bargaining Agreement.

#### **Band Staff**

It is recommended the school board approve the employment of the following band staff for the 2017-2018 school year:

Tina Pulver, Band Front Instructor - \$2,100 Robyn Rummings, Assistant - \$2,100 Marc Garside, Percussion Instructor - \$1,500

#### 4. TENURE – Attachment # 4

It is recommended the school board approve tenure for Melanie Shepheard. She will have completed three years of satisfactory teaching at South Williamsport Area School District at the end of the 2016-2017 school year.

# 5. <u>APPROVAL OF LETTER OF AGREEMENT WITH THE MEADOWS PSYCHIATRIC</u> CENTER – Attachment # 5

It is recommended the school board approve the Letter of Agreement between the South Williamsport Area School District and The Meadows Psychiatric Center to provide educational services. The agreement shall be in effect for the 2017-2018 and 2018-2019 school year.

It is recommended the school board approve the IDEA Agreement with BLaST Intermediate Unit #17 for the 2017-2018 school year. This provides federal funding for special education programs that qualify under IDEA Component III.

## **8. RESOLUTION ADOPTING THE 2017-2018 GENERAL FUND BUDGET** – Attachment # 8

It is recommended the school board approval of the final 2017-2018 budget resolution which includes revenue of \$18,955,366 and expenditures of \$19,525,409. There is a .65 mill increase included in the budget. The District is projected to use \$570,043 from committed and uncommitted fund balance.

#### 9. ADOPTION OF THE 2017-2018 TAX LEVY RESOLUTION – Attachment # 9

It is recommended the school board approve the Tax Levy Resolution to support the 2017 - 2018 General Fund Budget as follows:
