The regular meeting of the South Williamsport Area School Board was called to order at 6:00 PM in the High School Library by the President, Todd Engel.

The meeting opened with a Moment of Silence and Pledge to the Flag.

SUPERINTENDENT RECOMMENDATIONS

SCHOOL SAFETY AND SECURITY UPDATE

Mr. Michael Samar, School Police Officer, spoke to the board about school safety and security updates. He spoke about implementing a triad concept of school-based policing which consists of Educator/Presenter, Informal Counselor/Mentor, and Law Enforcement Officer. He spoke about security items purchased with grant programs and Title IV funds, including portable radios, security cameras, and HALO Smart Vape Sensors. He also spoke about the emergency response model referred to as "Run

Hide Fight" which was implemented in May 2022; this is a transition from the ALICE model which the District used in the past.

PROPOSED FINAL BUDGET FOR 2022-2023

A motion to approve the 2022-2023 proposed final budget with budgeted revenues of \$20,514,238 and budgeted expenses of \$20,515,354 with real estate tax millage of 18.41 mills, earned income rate of 1.1%, and real estate transfer tax rate of 0.5%, was moved by Bachman, seconded by Cramer. RESOLUTION TO INCUR DEBT

A motion to approve the resolution to incur non-electoral debt pursuant to the Local Government Unit Debt Act, and to evidence such indebtedness by the issuance of its General Obligation Bonds, Series of 2022, for the purpose of (1) planning, designing, acquiring, constructing, installing, furnishing, and equipping of alterations, renovations, additions and improvements to existing facilities of the School District; (2) purchasing capital equipment for use in or in connection with the facilities of the School District; (3) additional capital projects of the School District to the extend approved by the Board; and (4) paying the costs and expenses of issuance of Bonds was moved by Rupert, seconded by Engel. All members present voting yes, Mrs. Bachman was elected as Treasurer for the next year beginning in July.
